

For PayPal, you have two options.


The "easy button" is on our website under the "Renew Your Membership" tab which has a "Donate" button. However, due to the way PayPal buttons work on websites, you'll have to pay the associated fees which comes out to \$2.50. To avoid the fee, you can also log in to your PayPal account and send your dues "as a friend" directly to our account at paypal.weedwackers@gmail.com. You may see Scott Graupmann's name come up which is fine, as he's the treasurer holding the PayPal account open. In either case, please be sure to add either your full name or AMA number to the PayPal payment note. If we see only your PayPal login as "Im a catlover", we'll have no way of processing your dues.

<u>Gate Code Change</u> – An advantage to paying your dues by January 1<sup>st</sup> is that the gate combination changes on that day, and you

won't be issued the new code until you've renewed and get a new badge.

#### **Trailer Batteries for Charging Stations**

The bank of six 12-volt batteries we have connected to the solar panels and charging stations have met the end of their useful lives. Even at the charging stations against the storage shed and at closest electrical distance to the source, the bank has a hard time staying above 11.7 volts under even a small charging load. Jeff has taken an action to find suitable replacements.



<u>Flying over the Nursery</u> – To be clear, while there are no personnel working in the area just east of our runway (on the other side of the boundary fence), we're clear make our landing approaches over the property. I've asked the business owners (and they happily agreed) to park their vehicles on the south or east ends of their property to limit the chance of a problem during our landing approaches. However, the soil in those areas isn't yet compacted well enough for them to park safely, so you may see vehicles up against the eastern fence. It's incumbent upon us to keep our landing approaches high enough to avoid any incidents. When people are actively working at the property, *then* is when we can't fly over the area.

#### **Club Officer Elections**

As is captured in the minutes, the current club Officers retain our seats by acclamation, with no opposition. Let me personally thank the Officers for their continued service. To summarize, the Officers consist of myself as Prez (6<sup>th</sup> consecutive year, 8 years total), Jeff Coskey as VP (6<sup>th</sup> consecutive year), Scott Graupman is our Treasurer (15<sup>th</sup> consecutive!!!), and Bruce Allen as Secretary (8<sup>th</sup> consecutive!).

The Board of Directors includes the club Officers and our newsletter editor Don Westergren (41 years total service, 3 as Prez, 3 as Secretary and 35 years as editor in chief!).

Positions that I have appointed include our Safety Officer and Raffle Chairman Ron Keith (10 years), Webmaster Tim Peterson (8 years) and field marshals of various longevity (Vernon Gilmore, Ron Keith, Dick Milhausen, Butch Weiser, Gary Rold, Tim Peterson).

#### Social Distancing

On occasion we need to be reminded of the criticality of compliance with the Health Orders issued by the State, and the protocols and postings at the field.



This is one of those occasions, and much of what I'm saying below has been said before. - I've been told that it's nearly impossible to maintain social distances at the flying field. I challenge that belief and contend that it's actually quite simple. We have a lot of room in the pits. I often see conversations being held from ten feet. But there ARE those instances in which we find ourselves needing to close in to lend a helping hand or check out how busted up someone's plane is after a bounce. And there are also those instances in which people have been seen transiting from point A to B without a mask, and pass close to others without realizing it; or maybe while realizing it and not masking up.

#### I reiterate:

We're not going to tape 'X's or paint circles all over the flight line or pit area to create "safe zones". Our flying field is a dynamic area in which we enjoy moving about. We're not a gro-

cery store. We're more like the Santee Swap Meet - people milling about in free motion. - We're not going to put up even more signs that remind us to maintain social distancing. - What I'm going to do is to remind you all again that we're tasked with following this very simple protocol.

The California Department of Public Health requires that we must wear face coverings "while outdoors in public spaces when maintaining a physical distance of 6 feet from persons who are not members of the same household or residence is not feasible."

It's important that we observe this requirement. You must have a mask on your person, and if you approach someone to within six feet, put it on.

#### This is important!

While we all have a duty to help mitigate the spread of the virus, we have a couple of members who feel threatened and very strongly object to the fact that a few others don't adhere to the 6'/mask policy, regardless of their proximity to the concerned members. Those individuals have made me very aware, on several occasions, of their feelings on the matter. It's to the point now where I honestly fear that we are at risk of some action that could shut the field down for the duration of the COVID-19 pandemic.

#### Don't let this happen!

It's up to ALL OF US, Field Marshals, club Officers and members alike, to simply wear a mask when within six feet of others. Do your duty to protect each other and to protect our ability to enjoy our field!
